

A Meeting of the Llangurig Community Council was held on 21 December 2015 at 7.30 p.m. in the Church House. Councillors present were C C Davies (Chairman) I Bound, L Higgitt, J Lewis, P Jones and R Williams.

1. **Apologies** for absence were received from Cllrs M Bound, B Jones, G Jones and P Windsor.
2. **Declarations of Interest** – there were no Declarations of Interest.
3. **Minutes** of the 23 November 2015 – Cllr I Bound confirmed that he did not attend the meeting however Cllr M Bound was in attendance. Clerk to amend Minutes accordingly. It was proposed by Cllr J Lewis and seconded by Cllr R Williams that the Minutes should be accepted signed and dated as a true record.

Cllr J Lewis proposed and Cllr P Jones seconded in favour of the scheme however, the point should be made that there would be extra traffic exiting on to the A44.
